## Page 1 of 5 Important Information Prior to Travelling to Zimbabwe Passport and Tourist Visa Conditions

Australian ordinary passport holders are required to have a visa to enter Zimbabwe as a tourist. This can usually be obtained upon arrival at the port of entry and generally allows a stay of up to 30 days in Zimbabwe. The cost of a visa is US\$30 for single entry and US\$45 for double entry, travellers should carry small denominations of US dollars when entering and exiting Zimbabwe. Those also travelling to Zambia and entering through specific ports may be eligible to apply for a Kaza visa on arrival, which covers entry into both countries. Travellers are recommended to have at least two blank pages and six months validity on their passport from the date they intend to depart Zimbabwe, as well as documentary evidence of their onward/return travel arrangements and their ability to financially maintain themselves for the duration of their stay. Alternatively travellers may apply for a visa prior to departure from the Embassy of Zimbabwe in Canberra. Travellers are recommended to contact a Zimbabwean mission on the details below for further information and to ensure their specific circumstances make them eligible to receive a visa upon arrival in Zimbabwe (especially those under 18 years of age).

## Vaccinations and Health Precautions

The following information is intended as a guide only and in no way should it be used as a substitute for professional medical advice relative to a travellers individual needs and vaccination history. Vaccination against hepatitis A is recommended for travellers to Zimbabwe. Frequent or long stay travellers should consider vaccination against hepatitis B. Vaccination against rabies (particularly if working with animals) and typhoid (particularly when travelling to areas with poor sanitation and hygiene) should be considered by travellers to Zimbabwe. Cholera is reported in Zimbabwe but vaccination is generally not recommended. Care with food and beverage selection is far more important. There is a high risk of malaria in Zimbabwe and dengue fever also occurs, thus insect avoidance measures and anti malarial medication may be necessary depending on your itinerary. Do not swim in fresh water to avoid exposure to diseases such as schistosomiasis (bilharzia).

Regardless of destination, all travellers should be up-to-date with their routine "background" vaccinations including a recent annual influenza vaccination. Please consult a medical practitioner or contact The Travel Doctor for your specific risk to these preventable diseases and the appropriate avoidance measures.

Australians travelling to Zimbabwe should ensure that they have adequate travel insurance to cover the length of their stay. Medications that are legal in Australia may be illegal in other countries. ## Current Travel Advice from DFAT

This advice is current for Mon, 5th November 2018.

<u>Exercise a high degree of caution</u> in Zimbabwe due to the risk of crime and the possibility of civil unrest and political violence. Pay close attention to your personal security at all times. Political demonstrations can occur across Zimbabwe and become violent. The security situation could deteriorate quickly. See <u>Safety and security</u>. The US dollar is the most commonly used currency in Zimbabwe. In 2016, Zimbabwe introduced new 'Bond Notes' which have the same value as the US dollar. There is a cash crisis in Zimbabwe. Authorities have blocked international debit cards from making cash withdrawals from ATMs. Take sufficient cash to cover your needs for the duration of your stay. Check with hotels and other providers whether they accept card payments, especially outside of Harare. See <u>Safety and security</u>.

The current economic issues in Zimbabwe are contributing to an increase in crime and theft. Security risks are heightened at night. Some robberies have taken place during the day, particularly in high density urban areas. See <u>Safety and security</u>. The European Union has banned Air Zimbabwe flights to the EU due to safety standards issues. See <u>Local travel</u>. Road conditions in Zimbabwe are poor. Accidents are common. Drive carefully. Avoid driving at night. Sometimes there are fuel shortages. See <u>Local travel</u>. Health services in Zimbabwe are poor. Make sure you have comprehensive travel insurance that covers you for medical evacuation. On 6 September 2018, local authorities declared a cholera outbreak in Harare. See <u>Health</u>.

### General 5 Destination Page o f Information for Zimbabwe Duty Free Allowances for Zimbabwe and Australia

Duty Free limits when entering Zimbabwe: 5 litres of alcoholic beverages (only 2 litres of Alcohol: which may be spirits).

Other Goods: Up to a value of US\$300.

Duty Free limits when entering Australia: Alcohol: 2.25 litres of alcoholic beverages. Tobacco: 25 cigarettes plus one open packet of cigarettes. Other Goods: Up to \$900 (\$450 for minors)

Minors may not claim alcohol or tobacco products. The Zimbabwean limits are only applicable once per month. Further restrictions apply when entering/exiting Zimbabwe and Australia. Travellers are encouraged to familiarise themselves with these restrictions before crossing the borders of either country. 



# Zimbabwean Currency

The Zimbabwean dollar has been removed from circulation indefinitely. The most commonly used currencies for day to day transactions are the US dollar, the South African rand and the Botswanan pula (near the Botswanan border). In November 2016 Zimbabwe introduced \$1, \$2 and \$5 bond coins and notes that trade at par with the US\$.

Travellers cheques and credit/debit cards are not widely accepted in Zimbabwe. Although it is possible to withdraw cash from some ATMs, you should not rely on this service being available throughout the country. It is illegal to exchange foreign currency anywhere other than at officially licensed dealers (eg banks). The following images are for the US currency in general, travellers to Zimbabwe should carry small denomination notes as change is rarely available. As it is illegal in many countries to print copies of bank notes, travellers are advised to remove the below images prior to travelling.
