Current Travel Advice from the Department of Foreign Affairs and Trade

This advice is current for Mon, 5th November 2018.

<u>Exercise normal safety precautions</u> in Switzerland. Use common sense. Look out for suspicious behaviour, as you would in? Australia. There is a threat of terrorist attack in Switzerland. In recent years, terrorist attacks have occurred in a number of European cities. Terrorists are likely to plan attacks targeting Switzerland. Exercise caution in public places such as shopping areas, places of worship, sporting venues, public transport, airports and other transport hubs, and places of mass gathering. See <u>Safety and security</u>. Petty crime targeting tourists occurs, particularly around transport hubs in major cities. Crime rates increase during peak tourist seasons. See <u>Safety and security</u>. The weather in alpine regions is unpredictable and can change suddenly. You could encounter dangerous avalanches, flash flooding and mudslides. See <u>Natural disasters</u>.

Vaccinations and Health Precautions

Regardless of destination, all travellers should be up-to-date with their routine "background" vaccinations, including for Tetanus and Diphtheria (with a booster within the last 10 years), Whooping Cough, Polio (with a booster in adult life), Measles, Mumps and Rubella (two combination vaccinations through life), Chicken Pox and a recent annual Influenza vaccination. Vaccination against Hepatitis B should be considered for travellers to Switzerland if they are frequent travellers or intending on a long stay. Tick-borne encephalitis is present throughout many areas in Europe, predominately in forested regions. Whilst no vaccine is available in Australia, travellers visiting risk areas and planning outdoor activities during summer might consider vaccination once in Europe.

Please consult a medical practitioner or contact The Travel Doctor for your specific risk to these preventable diseases and the appropriate avoidance measures. Australians travelling to Switzerland should ensure that they have adequate travel insurance to cover the length of their stay. Medications that are legal in Australia may be illegal in other countries. Passport and Visa Conditions

Switzerland forms part of the Schengen Area. Australian passport holders are usually allowed to enter the Schengen Area for Tourism or Business purposes for up to 90 days in any 180 day period without a visa. The countries which make up the Schengen Area are Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden and Switzerland.

Travellers to the Schengen Area should ensure their passport is valid for at least six months beyond their intended stay. Travellers are also recommended to be able to provide documentation confirming their ability to financially maintain themselves during their stay, travel insurance covering the period of stay in the Schengen Area as well as tickets and entry documents for their onward destination. Males with (or eligible for) Swiss citizenship may be liable for military service or other obligations upon their return to Switzerland. For further information and to confirm that you are able to travel to the Schengen Area under this visa waiver program, please contact a Swiss mission on the details provided below.

Time Differences between Switzerland and Australia

Switzerland is Greenwich Mean Time +1 hour (+2 during daylight saving). The time zone is called Central European Time (CET) or Central European Summer Time (CEST). Daylight saving is observed from the last Sunday in March to the last Sunday in October.

Switzerland, 12 noon, December = Perth 7pm; Darwin 8:30pm; Brisbane 9pm; Adelaide 9:30pm; Hobart, Melbourne, Sydney 10pm. Switzerland, 12 noon, June = Perth 6pm; Darwin, Adelaide 7:30pm; Brisbane, Hobart, Melbourne, Sydney 8pm.

Duty Free Allowances

Duty Free limits when entering Switzerland:

Alcohol: 2 L of alcohol (up to 15% alc/vol) and 1 L of alcohol

(over 15% alc/vol).

Tobacco: 200 cigarettes or 50 cigars or 250 g of tobacco.

Other Goods: Up to 300 Swiss Francs.

Minors may not claim alcohol or tobacco products. For more information on Swiss customs please go to www.ezv.admin.ch. Further restrictions apply to these and other goods, travellers should familiarise themselves with these restrictions before entry.

Duty Free limits when entering Australia:

Alcohol: 2.25 L.

Tobacco: 25 cigarettes plus one open packet of cigarettes. Other Goods: Up to a value of \$900 (\$450 if under 18 years).



Electrical and Telephone Adaptors

Electrical Socket: Swiss (J type).

Voltage: 220-240 volts (same as Australia, no voltage/frequency converter required).

Special Tip: Standard European (C type) plugs will work with most Swiss outlets provided they are not set back deep into the wall with a six sided outer boarder (usually only in wet rooms such as bathrooms and kitchens).





Exchange Rate

Interbank Rate

1 Australian Dollar (AUD) = 0.72 Swiss Francs

1 Swiss Franc (CHF) = 1.39 Australian Dollars

Buy Rate (average rate when buying CHF cash in Australia) 1 Australian Dollar (AUD) will buy 0.69 Swiss Francs 1 Swiss Franc (CHF) will cost 1.46 Australian Dollars

All rates were correct at a point in time on Monday, 05 Nov 2018. The "Interbank Rate" does not take into account any exchange fees, while the "Buy Rate" adds 5.3% to the exchange rate to simulate a typical margin paid when exchanging these currencies. These rates have been rounded and should not be used when calculating transactions of large value.

Purchasing Power Parity

The following is a purchasing-power comparison of the Swiss Franc and the Australian Dollar, using the Big Mac as a common good. While it does not present a faultless comparison, it is a useful indicator of the purchasing power of each currency.

Big Mac Australia: \$5.95 (AUD) = 4.29 Swiss Francs
Big Mac Switzerland: 6.50 Fr (CHF) 9.01 Australian Dollars

A Big Mac in Switzerland is therefore 51% more expensive than in Australia.

This comparison is based on 2018 prices using current exchange rates. Prices may not include variations by locality or local taxes.

Banknotes of Switzerland

The legal currency of Switzerland is the Swiss Franc, which is abbreviated using the symbol "SFr" or "Fr". Each Franc is made up of 100 Rappen (centime in French or centesimo in Italian speaking areas). The following units of currency are the most common however other units are also in circulation including numerous coins and a 200 Fr and 1000 Fr note. Pictures are not to scale. As it is illegal in many countries to print copies of bank notes, travellers are advised not to take the below images with them when travelling.

Full Name: Swiss Confederation. Significant Dates: Schweizerische Eidgenossenschaft (German). 22 BC-401 AD - Celtic tribes of the Swiss plateau (inc.
