# This advice is current for Thu, 1st November 2018.

Exercise normal safety precautions in Fiji. Use common sense and look out for suspicious behaviour, as you would in Australia. Fiji will hold a general election on 14 November. Avoid any demonstrations, rallies and public gatherings in the lead up to, and during the election period. See <u>Safety and security</u>. Cyclone season is November to April. See <u>Natural disasters</u>. On 21 March 2018, the <u>Eiji Ministry of Health</u> declared an outbreak of meningococcal disease. Meningococcal can be highly fatal. Symptoms include high fever, sensitivity to light or nausea. See <u>Health</u>. Outbreaks of endemic mosquito-borne illnesses (including dengue fever) are common. Protect yourself against mosquito bites.

The only hyperbaric (decompression) chamber in Fiji is undergoing long-term maintenance. Dive well within safety limits and ensure your travel insurance covers diving and evacuation costs. See <u>Health</u>. Driving at night can be dangerous because of insufficient street lighting, stray animals and poor quality roads. Exercise caution. See <u>Local travel</u>. Expatriates and tourists have been the victim of violent crime, including sexual assault. Be vigilant. See <u>Safety and security</u>.

#### Vaccinations and Health Precautions

#### Prior to Travelling to Fiji Tourist Visa Conditions

Australian ordinary passport holders travelling for tourist purposes will usually be granted an entry visa on arrival at any designated point of entry into Fiji for a maximum period of 4 months. An extension of two months can be granted on application for a fee.

Passports are recommended to be valid for at least six months from the expected date of departure from Fiji (must be valid for six months from entry). Further conditions apply to those under 18 years of age.

Travellers should also be able to show documentary evidence confirming their ability to financially maintain themselves, confirmed accommodation arrangements for the duration of stay in Fiji and return/onward airline tickets and entry documents for their next destination.

Travellers are recommended to contact a Fijian mission on the details below for further information and to ensure their specific circumstances make them eligible to enter Fiji without a visa.

The following information is intended as a guide only and in no way should it be used as a substitute for professional medical advice relative to a travellers individual needs and vaccination history. No guarantee is made as to its accuracy or thoroughness. For further information, please contact The Travel Doctor on 1300 658 844.

Vaccination against hepatitis A is recommended for travellers to Fiji. Frequent or long stay travellers should consider vaccination against hepatitis B. Vaccination against typhoid should be considered by travellers to Fiji particularly if travelling to areas with poor sanitation and hygiene. As there is a risk of dengue fever and sporadic/limited transmission of the zika virus in Fiji, insect avoidance measures may be necessary depending on your itinerary, pregnant women should consider postponing travel to Fiji.

Regardless of destination, all travellers should be up-to-date with their routine "background" vaccinations, including a recent annual influenza vaccination. Please consult a medical practitioner or contact The Travel Doctor for your specific risk to these preventable diseases and the appropriate avoidance measures.

Australians travelling to Fiji should ensure that they have adequate travel insurance to cover the length of their stay. Medications that are legal in Australia may be illegal in other countries. Allowances when entering Fiji:Alcohol:2.25 L of spirits or 4.5 L of wine or 4.5 L of beerTobacco:250 cigarettes or 250 g of cigars or tobaccoOther Goods:Up to \$1,000 Fijian Dollars

Allowances when entering Australia:Alcohol:2.25 L.Tobacco:25 cigarettes plus one open packet of cigarettes.Other Goods:Up to \$900 (\$450 for minors).

Minors may not claim alcohol or tobacco products. Further restrictions apply when entering/exiting Fiji and Australia. Travellers are encouraged to familiarise themselves with these restrictions before crossing the borders of either country. #### **Electrical Adaptors and Voltage**

Supply: 220-240 V, 50 Hz (same as Australia).


As the electrical supply and connection systems in Fiji are the same as Australia, no converters should be required to use appliances designed for the Australian market.

All rates were correct at a point in time on Monday, 05 Nov 2018. The "Interbank Rate" does not take into account exchange fees, while the "With 4% Margin" adds 4% to the exchange rate to simulate a typical margin that would be paid when exchanging these currencies. These currency rates have been rounded and should not be used when calculating transactions of large value.

#### Information and Cheat Sheet Purchasing Power Parity

The following is a purchasing-power comparison of the Fijian Dollar and the Australian Dollar, using the Big Mac as a common good. While it does not present a faultless comparison, it is a useful indicator of the purchasing-power of the two currencies.

Big Mac Australia: \$5.95 (AUD) = 9.09 Fijian Dollars Big Mac Fiji: \$8.75 (FJD) = 5.73 Australian Dollars

A Big Mac in Fiji is therefore 4% less expensive than in Australia.

This comparison is based on 2018 prices using current exchange rates. Prices may not include variations by locality or local taxes.

The legal currency of Fiji is the Fijian Dollar, which is abbreviated using the symbol \$ or FJ\$ (for example FJ\$100). The subunit of the dollar is the cent, of which there are 100 in every dollar. 
