This advice is current for Thu, 1st November 2018.

<u>Exercise normal safety precautions</u> in Vanuatu. Use common sense. Look out for suspicious behaviour, as you would in Australia. <u>Do not travel</u> to Ambae island. Due to increased volcanic activity, the Government of Vanuatu evacuated the island on 26 July 2018, and declared a state of emergency to September 2018. See <u>Natural disasters</u>.

Vanuatu experiences natural disasters, including cyclones, flooding, volcanic activity, earthquakes and tsunamis. Cyclone season is November to May but cyclones can happen at any time. See <u>Natural disasters</u>.

Medical facilities are limited. Costs for treatment can be very high. If you become seriously ill or injured, you'll need to be evacuated.

Vaccinations and Health Precautions

Prior to Travelling to Vanuatu Passport and Tourist Visa Conditions

Australian passport holders usually do not require a visa to enter Vanuatu as a tourist for a period of up to 30 days. Passports should be valid for at least six months beyond the period of intended stay. Travellers should also be able to show documentation confirming their accommodation arrangements, their ability to financially maintain themselves during their stay, as well as tickets and entry documents for their onward or return destination.

A departure tax of VT3,000 per person is usually included in the cost of airline tickets. A provincial departure tax of VT200 is also applicable from several domestic airports.

Additional conditions may apply to minors. Travellers are recommended to contact a Vanuatu mission on the details below for further information and to ensure their specific circumstances make them eligible to enter Vanuatu without a visa.

The following information is intended as a guide only and in no way should it be used as a substitute for professional medical advice relative to a travellers individual needs and vaccination history. No guarantee is made as to its accuracy or thoroughness. For further information, please contact The Travel Doctor on 1300 658 844.

Vaccination against Hepatitis A is recommended for travellers to Vanuatu. Vaccination against Hepatitis B should be considered by frequent or long stay travellers. Vaccination against Typhoid should be considered particularly when travelling to areas with poor sanitation and hygiene. Malaria and Dengue Fever occur in Vanuatu, as such insect avoidance measures and preventative medication may be necessary.

Regardless of destination, all travellers should be up-to-date with their routine "background" vaccinations, including for Tetanus and Diphtheria (with a booster within the last 10 years), Whooping Cough, Polio (with a booster in adult life), Measles, Mumps and Rubella (two combination vaccinations through life), Chicken Pox and a recent Influenza vaccination.

Please consult a medical practitioner or contact The Travel Doctor for your specific risk to these preventable diseases and the appropriate avoidance measures. Australians travelling to Vanuatu should ensure that they have adequate travel insurance to cover the length of their stay. Medications that are legal in Australia may be illegal in other countries. 


